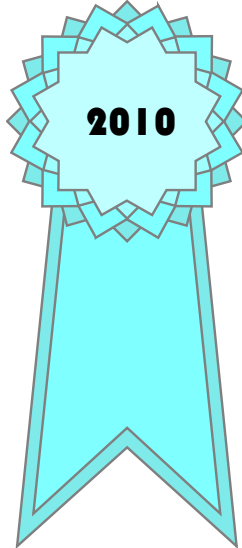

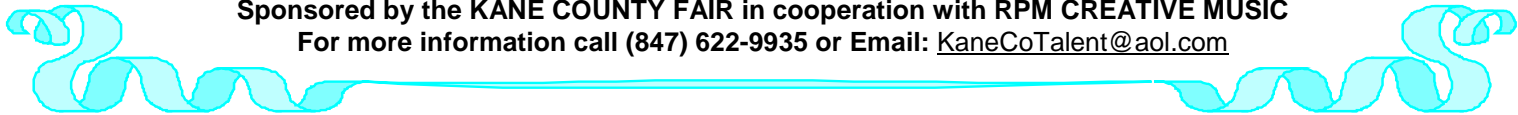

OFFICIAL RULES

1. Open to any person or group (school/organized group) residing in **KANE COUNTY**. The Contest is a "variety" contest and is open to **ALL** types of entertainment. Entertainment must be "wholesome" family type entertainment. Suggestive material, music or costumes may be cause for disqualification.

2. There are **TWO Divisions** (Proof of age may be required). JUNIOR DIVISION - Age 14 or under on 7-12-2010, SENIOR DIVISION - Age 15 - 21 or under on 7-12-2010

3. **AUDITIONS** will be held **Saturday, June 19, 2010** at **ST. PATRICK'S CATHOLIC SCHOOL**, 118 N 5th St., St. Charles, IL (Use main entrance on 5th St.) JUNIORS begin at 9:00 a.m. and **MUST SIGN IN NO LATER THAN 9:00 a.m.**, SENIORS begin at 1:00 p.m. and **MUST SIGN IN NO LATER THAN 1:00 p.m.** Participants will audition in the order that they sign-in upon arriving.

4. The **FINAL CONTEST** will be held **MONDAY, July 12, 2010** in a **PRE-Fair Showcase** in **THE FAIRGROUNDS JUDGING ARENA**.

***** JUNIOR DIVISION at 7:00 p.m., SENIOR DIVISION at 9:00 p.m. *****

5. YOU MAY ONLY PARTICIPATE IN 1 ACT. **RULES from the STATE:** I. A Junior Division contestant at the State contest cannot return to the State Level Junior Division again but may compete in the Senior Division provided they meet the age requirement. II. No Senior Division contestant can return to the State Contest as participants. **EXCEPTION:** In either division a contestant competing as a single can come back in a group or if in a group can come as a single, one time.

6. The **1st PLACE ACTS** of both the JUNIOR and SENIOR Divisions will **automatically represent KANE COUNTY** on JANUARY 15, 2011 at the Illinois Association of Agricultural Fairs Official Talent Contest State Competition. **NOTE:** If the 1st Place Winners are unable to compete, the 2nd Place Winners (runners-up) will become automatically eligible.

7. Your ACT may last NO LONGER than 4 minutes. Set-up time is limited to 3 minutes. **Any act exceeding these time limits will be disqualified.**

8. When using tapes or **STANDARD CD's** (no Mp3's please) for accompaniment, they **CANNOT** have **LIKE** talent on them - i.e. vocals, (either solo and/or background are not allowed), tap dancing, any like instrument, and so forth. **A VIOLATION OF THIS RULE WILL RESULT IN DISQUALIFICATION.**

9. **ALL ACTS** must be presented at the KANE COUNTY FAIR "FINALS" COMPETITION the **EXACT SAME WAY AS THEY AUDITIONED. COSTUMES** involved in the act **MUST BE WORN TO THE AUDITIONS.** Any change in costume and/or the ACT itself **will result in disqualification.**

10. Parents are encouraged to participate with preparations and should attend the Auditions and Final Contest.

11. Your ACT will be judged in 4 ways. They are: **TECHNIQUE** (Ability) - 25 points; **STAGE PRESENTATION** - 15 points; **AUDIENCE APPEAL** - 5 points; **APEARANCE** (Costume) - 5 points; a **PERFECT SCORE** is 50 points.

12. **FINALISTS will draw** for their positions in the **FINALS** immediately following the auditions.
